- ❖ **Fall Registration:** August 28 – September 7, 2017
- ❖ **Registration DEADLINE:** Thursday, Sept. 7 @ 4 pm. Hand-deliver or mail completed registration form with payment to: May Butler Center 55 S. Rodney - Helena, MT 59601
- ❖ **Payment** is due at time of registration.
 - * The cost is \$295 for ALL students (Check or Cash Only)
 - * No refunds given after a class begins.
- ❖ Student must turn **15** years old by: **December 31, 2017.**
- ❖ Classes are filled in **Date of Birth Order** with older students having class preference. We have a limited number of spots available; we do our best to fill classes the fairest way possible. We have hired on new instructors to help meet the demand!
- ❖ Class confirmation will go out via email by: **Wed, Sept. 20**

- ❖ All classes consist of 42 hours of classroom instruction, 12 hours of driving observation, and 6 hours of road instruction while at the wheel of a Drivers Education vehicle. **DRIVES:** Students will drive 6 times either after school (on days they do not have class) or on weekends. Driving time is scheduled by the instructor.
- ❖ Students are allowed **2** absences (make-up work assigned). Since class attendance is mandatory, consider family/student schedules: sports, vacations, jobs, etc. Third absence is an automatic “unsuccessful”.
- ❖ **Bring with you to Mandatory Meeting:** Parent/Legal Guardians Driver's License & a black ink pen
Two forms of Student ID: (Must be Originals or Certified Copies of documents)
 1. Student's Birth Certificate or Passport
 2. Student's Social Security Card or MT ID

**If you do not have these forms of Student ID start the process of getting them. They are required to take the course.*
