WHEREAS, Helena School District No. 1 ("District") must address the unforeseen emergency occurring at Hawthorne School pursuant to Section 20-3-322(5), MCA; and

WHEREAS, District staff informed the Board of Trustees that significant unforeseen damage to Hawthorne School has occurred due to the failure of the retaining wall and steps on the east side of the property; and

WHEREAS, the Board of Trustees are permitted to declare an unforeseen emergency and proceed with repairing property damage resulting from that emergency without complying with the procurement requirements of Section 20-9-204(3)(a), MCA; and

WHEREAS, the District declares the failure of the Hawthorne retraining wall and steps is an unforeseen emergency, and pursuant to Section 20-9-204(3)(a), MCA.

THEREFORE, BE IT RESOLVED: The Helena School District No. 1 Board of Trustees hereby resolves to declare the failure of the retaining wall and steps at Hawthorne School an unforeseen emergency pursuant to Section 20-3-322(5), MCA. The Board of Trustees authorizes the Superintendent of Schools to proceed with the repairs to the infrastructure without complying with the procurement requirements of Section 20-9-204(3(a), MCA.

Background:

Whenever the trustees determine that a levy proposition is not necessary, the district may cancel a levy election at any time prior to election day

Considerations:

- Under the present law, the highest levy that can be requested for the high school general fund is ten thousand thirty-three and 97 cents (\$10, 033.97).
- The high school district's average cost of running an election is approximately \$12,000. Therefore, it would not be fiscally sound to run the levy election.

Superintendent recommendation:

Cancel the high school district levy election

FOR HELENA ELEMENTARY/HIGH SCHOOL DISTRICT TRUSTEE NO. 1 FRUSTEE FHREE YEAR TERM (VOTE FOR THREE)

HELENA ELEMENTARY SCHOOL GENERAL FUND LEVY
Shall the board of trustees be authorized to impose an increase in local taxes to support the general fund in the amount of one hundred three thousand five hundred ninety-four DOLLARS (\$103,594) per year which is approximately 1.00 mill, for the purpose of: the general operations of the district?
Passage of this proposal will increase the taxes on a home with a market value of \$100,000 by approximately \$1.35 and on a home with a market value of \$200,000 by approximately \$2.70. The durational limit of the levy is permanent once approved by the voters, assuming the district levies that amount at least once in the next five years.

Recommendation to Approve the Ballot Language for the Elementary District Levy

I. NEW BUSINESS

A. Items for Action

Background:

Pursuant to 20-20-401, MCA, the election administrator prepares the final ballot form. Trustees must pass a resolution stating exact levy amounts by this date for the clerk to certify the ballot. This resolution must include the durational limit, if any, on the levy.

Considerations:

- Under the present law, the highest levy that can be requested for the elementary general fund is one hundred three thousand five hundred ninety-four DOLLARS and sixty-five cents (\$103,594.65), which is approximately 1.00 mill. Passage of the proposal will increase the taxes on a home with a market value of \$100,000 by approximately \$1.35/year and on a home with a market value of \$200,000 by approximately \$2.70/year.
- There are three open trustee positions. Two candidates have filed nomination petitions, Libby Goldes and John McEwen. The deadline for filing a declaration of intent to be a write-in candidate is 5:00 pm on April 4, 2019. If the number of candidates filing a nomination petition or filing a declaration of intent to be a write in candidate is equal to or less than the number of open trustee positions, the trustee election will be cancelled.

Superintendent recommendation:

Approve the attached ballot language.
