Sarah Sullivan stated, "That has been asked for in the past...there seems to be a hesitancy...". Superintendent Ream stated, "They don't want to upset communities by moving projects around [if there are special circumstances] ...". Luke stated, "By not having that list, are we really preventing people from setting expectations that we cannot follow in case of emergencies?". "I don't think it's a good idea, they see them as hard and fast, it should be getting done...it just doesn't work out that way...", stated Sarah.
