# **Summary of the Work:**

The Haunting of Hill House takes place over a single week in the 1950's rural America. The story begins with Dr. John Montague, a psychic researcher, who realizes Hill House, built some 80 years before, is a true haunted house. Dr. Montague seeks out volunteers including Eleanor, thirty-two, who comes to the attention of Dr. Montague because of an incident involving a poltergeist when she was twelve. She has spent most of her life caring for her invalid mother, and is shy, repressed, and looking for her identity. The physical horror of Hill House is subtle; more disturbing is the emotional torment Eleanor endures. Eleanor's summer stay at Hill House along with the three other guests proves to be a psychological journey of the imagination turned evil.

#### Rationale:

English IV, M\*A\*S\*H, mystery, adventure, suspense and horror, is a section of the required English IV course. This course emphasizes the analysis of non-fiction and novels. Students should have an appreciation for and love of reading.

The Haunting of Hill House is a classic novel from the horror genre. It uses the subtle techniques that were part of the early horror genre. Elements of The Haunting of Hill House can be found in Stephen King and other horror fiction writers. Shirley Jackson is an important American writer whose short story "The Lottery" is a part of the American

The Haunting of Hill House has been the premise for a number of horror films. Students will be familiar with the plot.
