**Item Title: Presentation
 Helena Advanced Services Report - Dr. Jonathan Plucker**

Evaluation of Advanced Education Services in the Helena Public Schools

The purpose of this project was to evaluate the Helena Public Schools' services to support advanced learning. HPS advanced education has proven to be contentious in recent years, and the District leadership and Board of Trustees sought a third-party analysis of these services. In addition, the project was expected to provide recommendations for program improvement.

About the Evaluator

Jonathan Plucker is a Professor at the Johns Hopkins School of Education. Previously, he served as the Associate Dean for Faculty Affairs and the Julian C. Stanley Endowed Professor of Talent Development at Johns Hopkins, Raymond Neag Endowed Professor of Education at the University of Connecticut, and Professor of Educational Psychology and Cognitive Science and Associate Vice Provost for Research at Indiana University. He graduated with a B.S. in chemistry education and M.A. in educational psychology from the University of Connecticut, then after briefly teaching at an elementary school in New York, received his Ph.D. in educational psychology from the University of Virginia.

In his time at Indiana University, he was the founding director of the Center for Evaluation and Education Policy and led over 200 research and evaluation efforts that took place in all 50 states and several other countries. These projects covered a wide range of education topics, from largescale evaluations the Cleveland voucher program and Indiana and Georgia charter school systems, to evaluations of state after school programs to evaluations of instructional materials for gifted students in Ohio. For several years, he served as the primary provider of evaluation technical assistance for grantees of the Office of Innovation and Improvement at the U.S. Department of Education. He frequently conducts evaluations of school districts' advanced education programs.

Dr. Plucker is an APA, APS, AERA, and AAAS Fellow and recipient of the Arnheim Award for Outstanding Achievement in the Psychology of Creativity from APA and the Distinguished Scholar and Distinguished Service Awards from the National Association for Gifted Children. He is a past-president of the Society for the Psychology of Aesthetics, Creativity, and the Arts and of the National Association for Gifted Children. He serves as principal investigator for the National Research Center on Advanced Education. Dr. Plucker was assisted during this project by Jennifer Madsen, a parent advocate who serves on the board of directors for the New Jersey Association for Gifted Children and the National Association for Gifted Children. Ms. Madsen has extensive experience conducting interviews and focus groups with parents of advanced and twice-exceptional students.

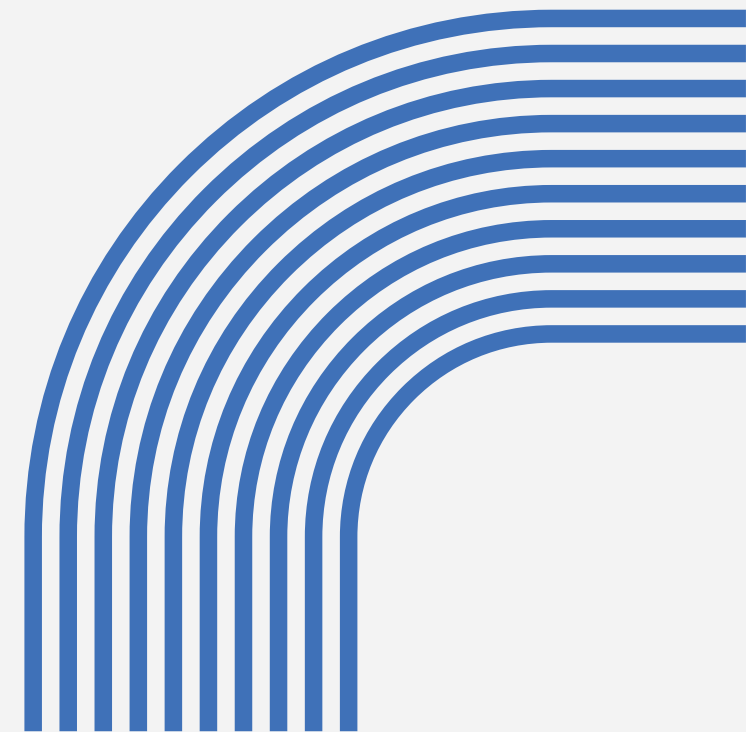

High School Baseball Update





Current AA Status

- **14 out of 16** AA schools are playing high school baseball **this** spring
- The two Helena schools are the **only** AA schools **not** playing



Research Supports...

Key Research Findings

- ✓ Students who participate in organized sports report **lower rates of anxiety and depression** compared to non-athletes.
- ✓ Team sports participation has been linked to a **stronger sense of school belonging**, which significantly reduces depressive symptoms in adolescents.
- ✓ High School athletics provide students with:
 - positive peer connections
 - trusted adult mentors
 - structure and accountability



Ridgeway Settlement



- Equal number of male and female sports is first compliance indicator for meeting Ridgeway requirements (**we currently have 1 more girl's sport (wrestling) than boy's**)
- If out of compliance, there are various measures that are used to determine if appropriate opportunities are available:
 - A student interest survey is one of the first steps
- *“If the explicit and deliberate efforts of a school district to equalize sports for females and males result in a survey of interest demonstrating that a particular sport would receive sufficient support to field a team, the school district shall add that sport to the extent of the financial ability of the school” (Ridgeway Settlement, 1982)*



Student Interest Survey

Survey Results



976 Total Respondents.

- 473 (48%) Male, 453 (47%) Female, 40 (4%) Prefer Not To Answer
- 570 Middle School Respondents
- 406 High School Respondents



Baseball

Baseball (**38%**) came in a solid second of surveyed students as their choice boy's sport in the spring





Title IX Three-Prong Test



The Title IX Three-Prong Test is used to determine whether a school is providing equal athletic participation opportunities for males and females. A school only needs to meet one of the three prongs to be considered compliant.

- **Substantial Proportionality** - Athletic participation opportunities are substantially proportionate to the school's overall male and female enrollment.
- **History and Continuing Practice of Program Expansion** - The school has a demonstrated history of expanding athletic opportunities for the underrepresented sex.
- **Full and Effective Accommodation of Athletic Interests** - The school is fully meeting the athletic interests and abilities of the underrepresented sex through its current programs.

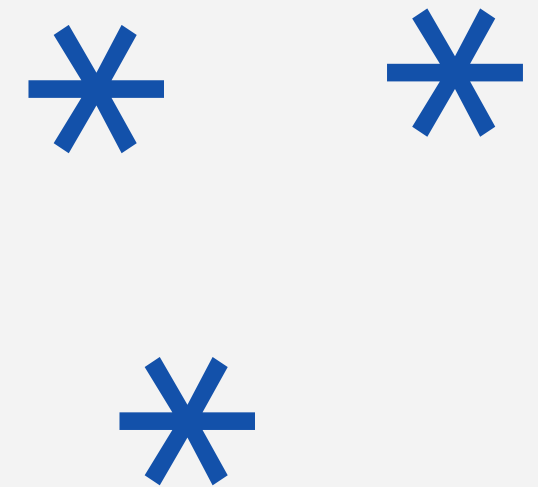
Absences

IV. PRESENTATION: 2025 District Audit: Tony Gerharz, Manager, Wipfli LLP

The Board of Trustees received a presentation on the Helena Public Schools 2025 District Audit from Tony Gerharz, Manager, Wipfli LLP. Mr. Gerharz reported that the audit resulted in an unmodified opinion, indicating the financial statements are accurate and reliable. No findings were identified related to internal controls or compliance with federal funding requirements. He noted minor challenges related to timing of federal documentation, which did not delay the audit process. The audit also included a review of the district’s child nutrition program, with no issues identified. Additionally, a new accounting standard related to compensated absences was reviewed, with no changes required to the district’s reported liabilities. Mr. Gerharz addressed questions from the Board of Trustees.

- Mentoring Program – Superintendent Weltz, along with Jane Shawn, Maria Foot, Jake West, and Jill Putnam, presented an update on the District’s mentoring program. The team shared that the program is designed to complement existing Professional Learning Communities by focusing on building district knowledge, fostering connections beyond grade-level teams, and supporting new staff through mentorship relationships. Presenters highlighted strong early interest, with over 35 mentor applications submitted within the first five days. Key components of the program include mentor training, a comprehensive handbook with resources and expectations, structured checklists to guide mentor-mentee interactions, and an emphasis on relationship-building and staff well-being. The program will also include mid-year and end-of-year surveys to evaluate effectiveness and inform continuous improvement. The team noted ongoing collaboration with Human Resources and district leadership to support implementation and mentor matching, with plans to continue development over the summer. That concluded the Superintendent’s Report portion of the agenda. Superintendent Wertz responded to questions from the Board of Trustees, after which the trustees proceeded to hear general public comment.

VI. GENERAL PUBLIC COMMENT

Ms. Amanda Osborne provided general public comment. Ms. Osborne is a parent of students in the district. Ms. Osborne’s general public comment addressed several key topics, including but not limited to the following: student cell phone use in schools; concerns regarding the impact of cell phones and social media on student learning, attention, and mental health; national and international efforts to limit youth access to social media; and the consideration of policies to restrict or limit cell phone use during the school day, with an emphasis on prioritizing student well-being.

Ms. Courtney McAdams provided general public comment. Ms. McAdams is a parent of a student in the district. Ms. McAdams’ general public comment addressed several key topics, including but not limited to the following: student cell phone use and its impact on engagement; support for district funding measures alongside a request for increased transparency; the need for greater communication of academic performance data and outcomes; comparisons to practices in other districts; concerns regarding curriculum implementation timelines; and student achievement data, including proficiency rates and ACT performance, with an emphasis on prioritizing academic outcomes.

Ms. Danita Light provided general public comment. Ms. Light’s general public comment addressed several key topics, including but not limited to the following: support for and participation in dual enrollment and alternative programs, including PEAK and Explore School; advocacy for continued funding and support of these programs; the importance of inclusive educational opportunities for neurodivergent and homeschooled students; and appreciation for district staff and programs that provide flexible, supportive learning environments.

The Board of Trustees took a brief recess and then proceeded with the Facilities Bond Projects updates.

VII. NEW BUSINESS

A. Items for Information - Facilities Bond Projects Updates

1. Kessler Elementary School Update

Representatives from Mosaic provided an update on the Kessler Elementary design process. The presentation highlighted ongoing collaboration with project partners and continued progress through schematic design. The design reflects input gathered from students, staff, and the community, with an emphasis on inclusion, student belonging, whole-child wellness, and connections to the surrounding natural environment. Presenters reviewed key design elements, including the organization of the building around a central “heart” space, learning neighborhoods, and community areas. Updates also included site-responsive features such as integration with the hillside, preservation of views, and access to outdoor learning and play spaces. Additional

highlights included plans for a student-informed mural to be incorporated into the new building and continued development of floor plans and building layout. Representatives from Mosaic addressed questions from the Board of Trustees regarding the information presented.

2. Capital High School Update

Representatives from Slate/RTA Architecture provided an update on the Capital High School design process. The team reported that the schematic design phase has been completed and submitted, with ongoing collaboration between design teams, contractors, and district staff to review plans and ensure alignment with budget expectations. The presentation highlighted the complexity of phasing construction while maintaining a fully operational school, including plans for multiple phases, temporary classroom spaces, and summer work to address demolition and abatement. Updates also included site and facility improvements focused on safety, traffic flow, and accessibility, as well as the addition of new and renovated learning spaces, including Career and Technical Education (CTE) areas, activity spaces, and a central “heart” for student use. The design emphasizes modern, student-centered learning environments, improved campus organization, and enhanced safety and visibility. Ongoing engagement with staff and students continues to inform the project as planning progresses. Representatives from Slate/RTA Architecture addressed questions from the Board of Trustees regarding the information presented.

Mr. Tim Meldrum of SMA/A&E and Bob Heberly with Dick Anderson Construction provided an update on the Helena High School campus project. The team reported that the design development phase is nearing completion, with continued collaboration among design and construction partners to finalize plans and prepare for upcoming pricing and bidding processes. Updates included progress on the district kitchen project, which is advancing toward completion of construction documents and anticipated groundbreaking in the coming months. The kitchen design focuses on operational efficiency, including production, storage, and distribution functions, along with site improvements for access and logistics. The presentation also included updates on the Helena High School and Project for Alternative Learning (PAL) facility designs, which continue to be refined based on stakeholder input. Project planning includes phased construction and coordination of timelines, with early construction activities expected to begin soon. Ongoing coordination with contractors and subcontractors is supporting cost estimates, material selection, and overall project readiness. Representatives from SMA/A&E and Dick Anderson Construction addressed questions from the Board of Trustees regarding the information presented.

The Board of Trustees took a brief recess and, upon returning, proceeded to review the Items for Information.

B. Items for Information

1. Policy 2085: Graduation Requirements

Ms. Keri Mizell, Human Resources Director, presented the information item, *Policy 2085: Graduation Requirements*. This policy is updated to reflect graduation requirements in alignment with state standards as well as revised language on waiver of requirements. New language has been added on the ability to achieve credit toward graduation requirements for participation in identified alternative programs. Administration addressed questions regarding the policy.

2. Policy 4000: Public Relations

Ms. Keri Mizell, Human Resources Director, presented the information item, *Policy 4000: Public Relations*. The policy outlines the District's commitment to maintaining open communication with the public, providing opportunities for community input, and ensuring transparency in decision-making. It also establishes the Superintendent's responsibility for developing communication programs and encourages Board and staff engagement with the community through various outreach efforts. Ms. Mizell addressed questions from the Board of Trustees regarding the information presented.

3. Policy 7050: Food Services

Ms. Keri Mizell, Human Resources Director, presented the information item, *Policy 7050: Food Services*. This policy is presented for periodic review, with updates made to reflect current governing authorities and applicable guidelines. It affirms the District's support of the National School Lunch Program by providing nutritious, appealing meals to students. The District may utilize certain federal funds to provide free meals for eligible students and will incorporate federally provided food commodities into meal preparation. Free and reduced-price meals are offered in accordance with federal and state guidelines, with families informed of eligibility criteria and student participation kept confidential; parents retain the right to appeal eligibility determinations. The District does not accept food donations without Board approval, and any approved donations must meet applicable safety and legal standards. Meal prices are established to fully cover the cost of food service operations, including labor, food, and related expenses. Ms. Mizell addressed questions from the Board of Trustees regarding the information presented.

The Board of Trustees moved on to review the Consent Action Items.

Mr. Eric Peterson, Activities Director, presented the proposed addition of a Girls Flag Football program. The presentation included an overview of growing statewide participation, student interest survey results indicating strong interest among female students, and the program’s alignment with equity considerations under Title IX and the Ridgway Settlement. Mr. Peterson noted that the program is currently recognized as an emerging sport by the Montana High School Association, with the potential for full sanctioning in the future. He also highlighted minimal startup and ongoing costs, supported in part by grant funding. The administration recommended approval of the program as a way to expand student opportunities and engagement. Mr. Peterson addressed questions from the Trustees regarding the information presented.

Board Chair Jennifer McKee entertained a motion to approve the *Helena Public Schools Girls Flag Football Program*.

2. Policy 2010: Instructional Program

Ms. Keri Mizell, Human Resources Director, presented the action item, *Policy 2010: Instructional Program*. This policy is up for periodic review with no substantive changes. The policy outlines that the School District provides instructional programs for grades pre-kindergarten through twelve and that the grouping and housing of instructional levels within school facilities are determined by plans developed by the Superintendent and approved by the Board. The policy also states that students are assigned to classrooms or instructional groups based on factors such as class size, peer relationships, student–teacher relationships, instructional style, and other considerations intended to best support the needs of individual students while balancing the needs of others. Ms. Mizell addressed questions from the Board of Trustees regarding the information presented.

Board Chair Jennifer McKee entertained a motion to approve *Policy 2010: Instructional Program*.

3. **Policy 2070: Network Information and Communication Systems**

Ms. Mizell presented the action item, *Policy 2070: Network Information and Communication Systems*. This policy governs student and staff use of District computer systems, networks, and Internet access for educational purposes. It emphasizes responsible and lawful use, with supervision by staff and accountability for misuse. Network access is a privilege and may be suspended or withdrawn for violations of the District's Acceptable Use Procedures, which require parental and student acknowledgment for minors. An update to the policy was made to include language on the responsible and appropriate use of Generative Artificial Intelligence (GAI) tools, aligning with the HPS Student Handbook. The policy clarifies that communications over District networks are not private, outlines security and indemnification responsibilities, and directs the Superintendent to provide training and procedures to ensure broad, lawful, and effective access to District technology resources. Ms. Mizell addressed questions from the Board of Trustees regarding the information presented.

Board Chair Jennifer McKee entertained a motion to approve *Policy 2070: Network Information and Communication Systems*.

- We just finished ACT testing and Seal of Biliteracy testing, and I know everyone who participated did a great job.

Recognitions:

- Congrats to our Mock Trial groups who did great at state. Our Team A took first, while our Team B took second. This is the seventh straight championship for HHS.
- Congrats to our eight athletes who signed to continue their athletic careers in college.

Upcoming Events:

- April 23 is our NHS induction ceremony at the HMS Auditorium at 6:30 p.m.
- AP testing starts in the first week of May.
- And the state music festival is in Helena during the Vigilante parade weekend.”

Mr. Gardipee addressed questions from the Board of Trustees regarding the information presented.

2. Helena Education Association Report

Ms. Jane Shawn, Helena Education Association (HEA) President, presented the Helena Education Association report. Ms. Shawn reported on the Montana Federation of Public Employees (MFPE) annual conference, including the election of a Helena teacher as MFPE President. Ms. Shawn also shared information about ongoing advocacy efforts related to the Respect Campaign, which focuses on wages, fairness, and unemployment eligibility for education support professionals. She noted upcoming participation in a statewide Day of Action at the Capitol and additional professional development opportunities focused on member engagement and organizing. Ms. Shawn addressed questions from the Board of Trustees regarding the information presented.

3. Facilities & Technology Committee Report

Trustee Siobhan Hathhorn presented the Facilities & Technology Committee report. Updates included progress on relocating warehouse facilities to accommodate the new district kitchen project, with materials moved and remaining structures being removed or repurposed at no cost to the district. Additional updates included site cleanup efforts and potential future lease considerations. Trustee Hathhorn reported on recent facilities incidents, including a sprinkler-related water event at Helena High and a power-related equipment issue at Capital High that resulted in a small fire and insurance claim; both have been addressed. Ongoing efforts to manage operational costs were noted, including equipment replacements to reduce supply expenses. Environmental testing at Rossiter continues, with results to date below regulatory levels of concern. Technology updates included ongoing state reporting requirements, administration of ACT and PreACT testing, system upgrades, and equipment replacements. Safety and communication systems were also reviewed and tested, with minor issues identified and addressed. Additional updates included improvements to the district print center and continued efforts to support communication regarding upcoming levies. Trustee Hathhorn addressed questions from the Board of Trustees regarding the information presented.

4. Teaching & Learning Committee Report

Trustee Jenny Murnane Butcher presented the Teaching & Learning Committee report. She highlighted the development of a new analytics and insights platform that provides access to

student benchmark data and allows for analysis by subgroup, classroom, and district levels. The tool is supporting more responsive instructional practices by helping educators use formative assessment data effectively. Additional updates included the review of intervention curriculum efforts in primary grades, with early data indicating successful outcomes at certain schools and potential for broader application across the district. Trustee Murnane Butcher addressed questions from the Board of Trustees regarding the information presented.

5. **Budget and Finance Committee Report**

Trustee Jenny Murnane Butcher presented the Budget and Finance Committee Report. Trustee Murnane Butcher reported that the district's budget remains in a healthy position as the fiscal year nears completion. The committee reviewed expenditure data, including salary and benefit costs compared to operations and maintenance expenses, noting continued improvement in overall budget health and reduced reliance on interlocal funds for operational costs. The importance of maintaining healthy interlocal balances to support future Moody's ratings and upcoming bond issuances was discussed. The committee also reviewed anticipated year-end interlocal fund activity related to building supply purchases and potential special education costs. In addition, the committee received an update on bond finances and reviewed preliminary budget planning for the upcoming school year, including retirements, staffing changes, and early retirement incentives. Trustee Murnane Butcher addressed questions from the Board of Trustees regarding the information presented.

6. **Policy Committee Report**

Ms. Keri Mizell, Human Resources Director, presented the Policy Committee Report. Ms. Mizell reported that a significant portion of the meeting focused on reviewing the Administration of Medication policy. The committee worked collaboratively with district nurses to gather feedback and ensure the policy aligns appropriately with district procedures. Ms. Mizell noted that the policy had become outdated over time, and the committee is working to strengthen and refine it through a collaborative process. Additional work is needed, and the policy will return to the Policy Committee for further review before being brought forward to the Board in the coming months. Ms. Mizell addressed questions from the Board of Trustees regarding the information presented.

7. **Health Benefits Committee Report**

There was no Health Benefits Committee Report this evening.

8. **Wellness Committee Report**

There was no Wellness Committee Report this evening.

9. **Montana School Boards Association Report**

Trustee Siobhan Hathhorn presented the Montana School Boards Association report. Trustee Hathhorn reported that the recent meeting primarily focused on internal strategic planning. She also shared updated information regarding legislative funding for education, bonds, and levies over time, noting that programs such as the STARS Act have provided meaningful support for

school funding. However, she noted that Montana schools still remain behind many comparable states in overall education funding, indicating that additional work remains to be done. Trustee Hathhorn addressed questions from the Board of Trustees regarding the information presented.

10. Parent Council Visit Reports

The Board discussed temporarily removing Parent Council visit reports from the meeting agenda due to the significant number of meetings and limited trustee availability throughout the year. Trustees expressed continued support for attending Parent Council meetings and recognized the value of trustee participation and community connection. The Board agreed to pause the agenda item over the summer, with the possibility of revisiting the process in the future, including consideration of assigning trustees to specific schools.

This concluded the reports portion of the agenda. The Board of Trustees then moved on to review upcoming meetings.

Board Chair Jennifer McKee reviewed upcoming committee and Board meetings with the Board of Trustees and Superintendent Weltz.

1. Approval of Resolution Requesting County to Conduct 2027 Elections

Background:

Pursuant to 20-20-417, MCA, the trustees of a district may request the county election administrator to conduct certain school elections during the ensuing school fiscal year. The request must be made by a resolution of the board of trustees. Whenever the county election administrator agrees to conduct a school election, the administrator shall perform the duties imposed on the trustees and the clerk of the district for school elections and deliver to the trustees, for the purpose of canvassing the vote, the certified tally sheets and other election items needed for canvassing the vote.

Considerations:

- The county election administrator has agreed to run elections scheduled for the regular election day, May 4, 2027.
- If a special election is requested, the county election administrator would want to find an agreeable date for the election and may refuse to run elections on a date that does not work for election office.
- The District must provide copies of all candidate filing forms and any ballot issue language by the candidate filing deadline.
- The county election office will run the election by district, not by precinct. Requests to run the election by precinct will not be accommodated.

Approve the attached resolution requesting the county to conduct 2027 elections for Helena School District No. 1.
